If you wish to pay direct into the DSBA bank account, the **Sort Code is 30:96:06 Account Number 01831195**, using your flock number as the payment reference.

This form only needs to collect data for lambs that are to be retained for breeding. For lambs that in your opinion, do not meet the breed standards, do not apply for a DSBA tag. General advice is always to keep only the best for your flock and for breeding.

Only the breeder can register lambs and this must be done within a year of birth.

Only progeny from DSBA registered ewes and rams are eligible for entry into the Flock Book.
